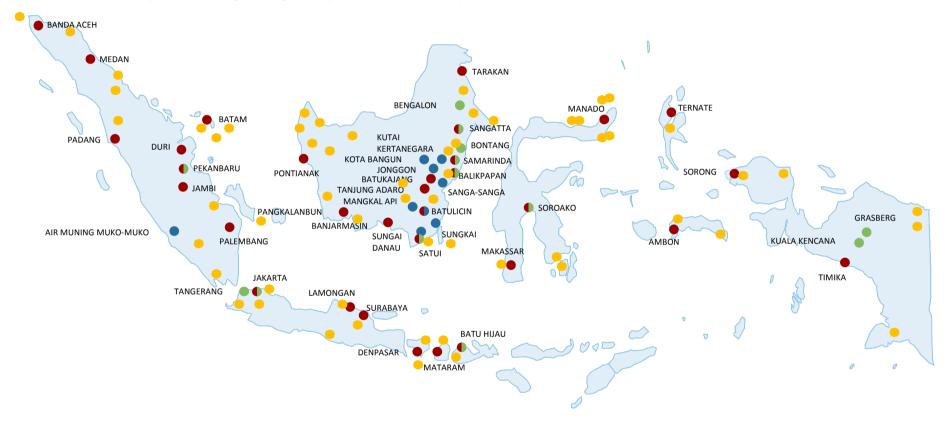

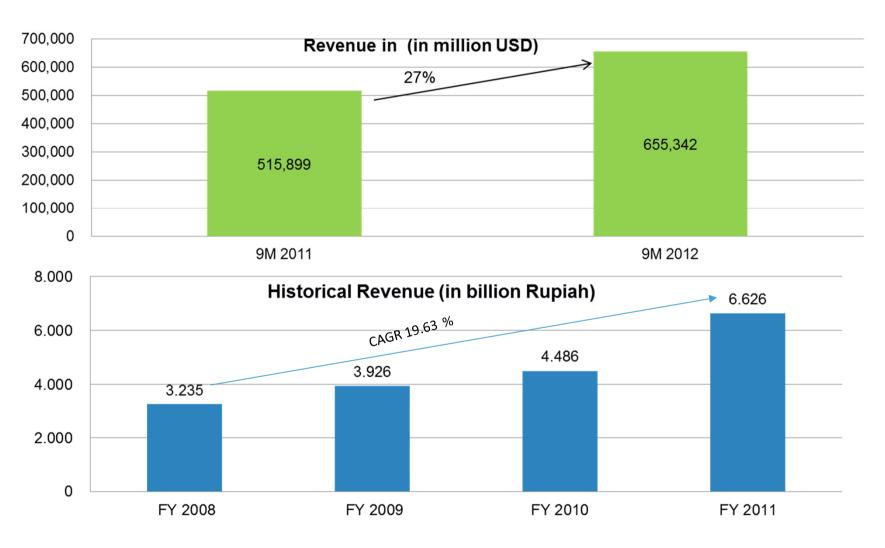

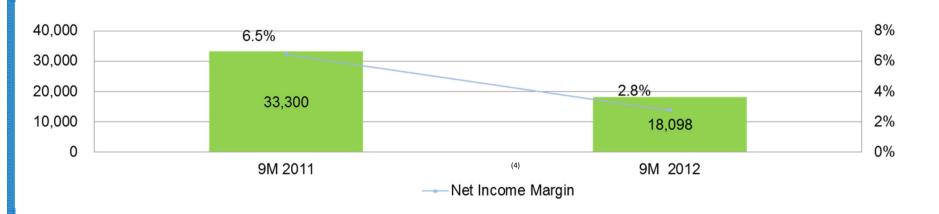
Revenue: Historical and 9M 2012



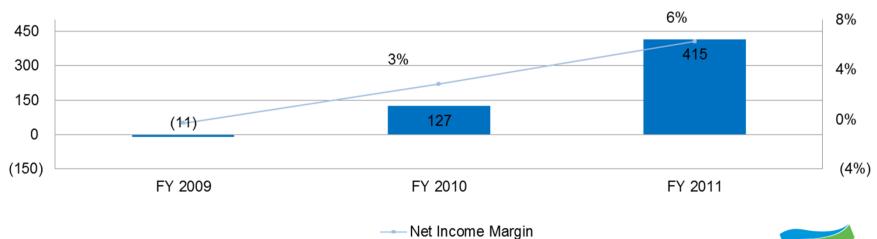


Net Income: Historical and 9M 2012

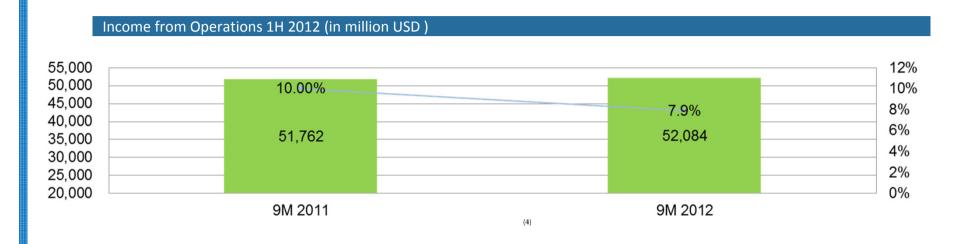
Net Income- 1H 2012 (in million USD)

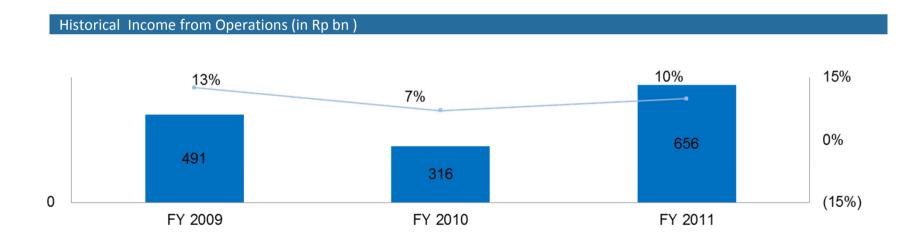


Historical Net Income- Year Ended Dec 31- IDR Bn

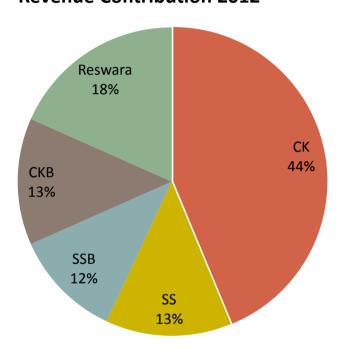

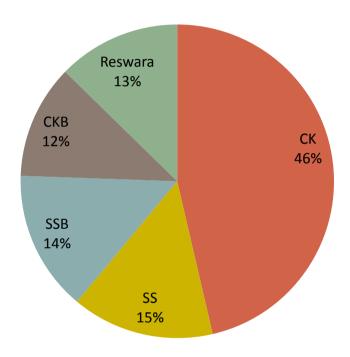

Revenue Contribution 2012



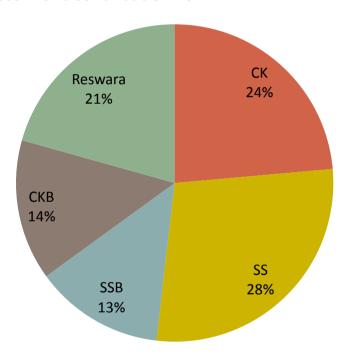
Revenue Contribution 2011



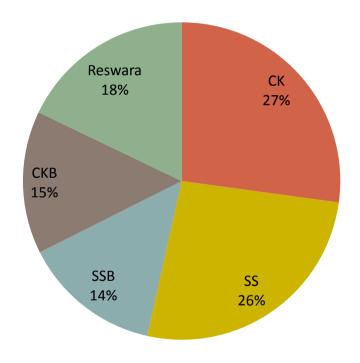

Gross Profit Contribution 2012



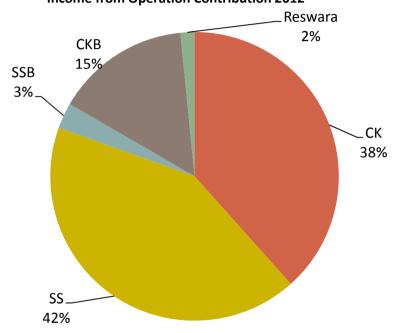

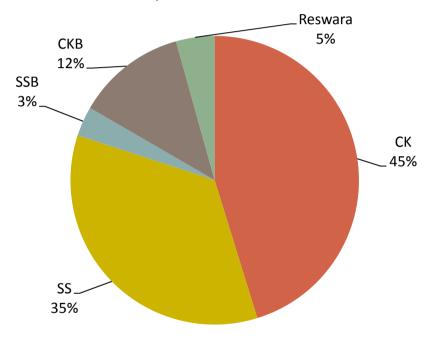

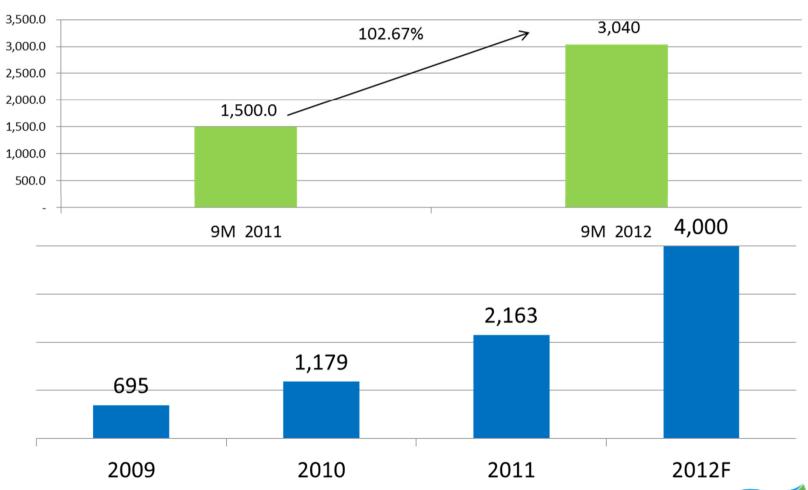


Reswara, Our Coal Production Unit

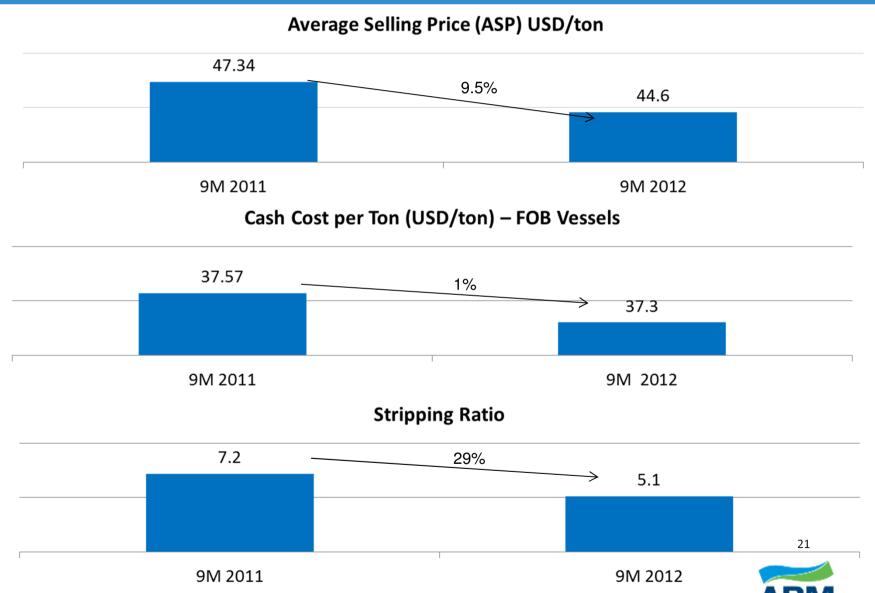


Sales and Production 1H 2012

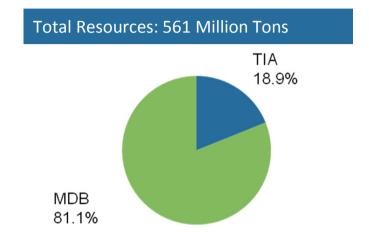
Reswara Sales & Production (in thousand tons)

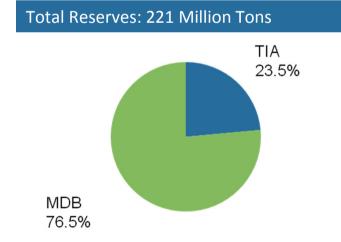


Average Selling Price (ASP), Cash Cost and Stripping Ratio

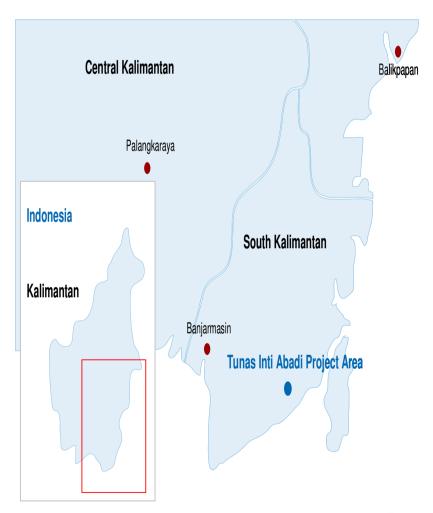


TIA Site Layout – Concession Area

PT Tunas Inti Abadi

- TIA was acquired in Dec 2007, commenced commercial production in Aug 2009 and coal sales in Oct 2009
- Coal mining is contracted to ABM subsidiary, CK
 - 25 km from pit to port at Bunati
 - 9-12 km from port to anchorage point at Bunati
 - 8,000 ton barge loading capacity at jetty
 - 120,000 tons temporary pile facility at the mining pit
 - Logistic advantages: Close to the Ocean

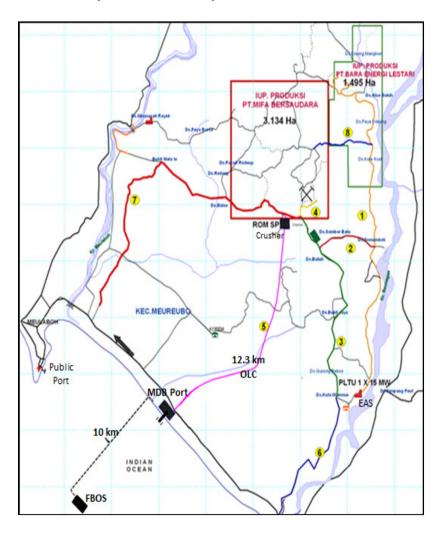

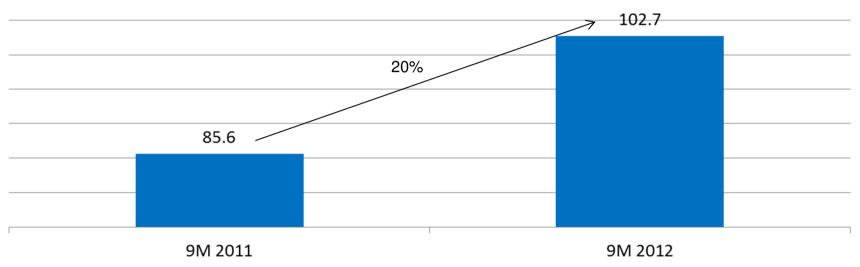

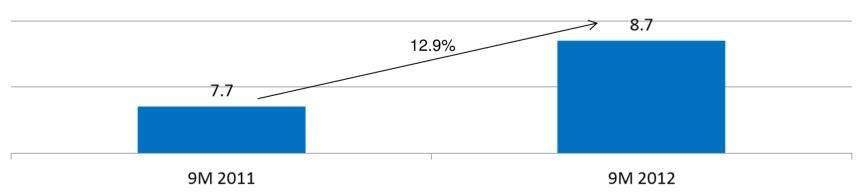


Overburden and Rental Services 9M 2012





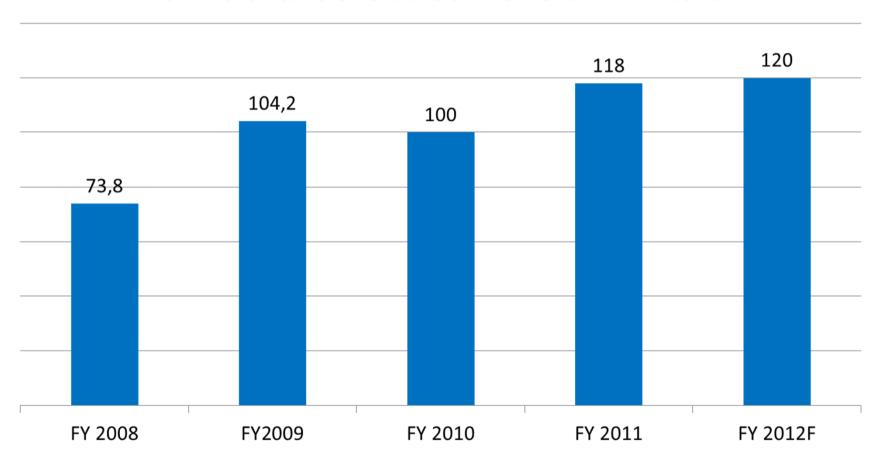
Rental Service in Mn Tons





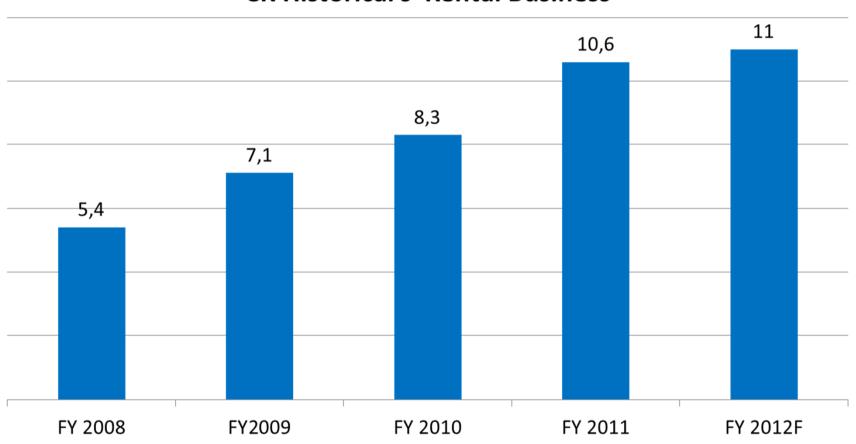
CK Overburden 2008-2011

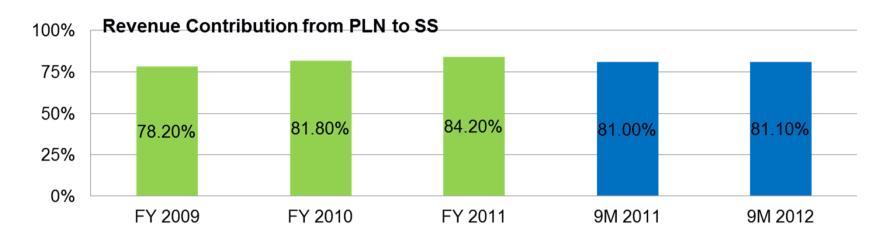

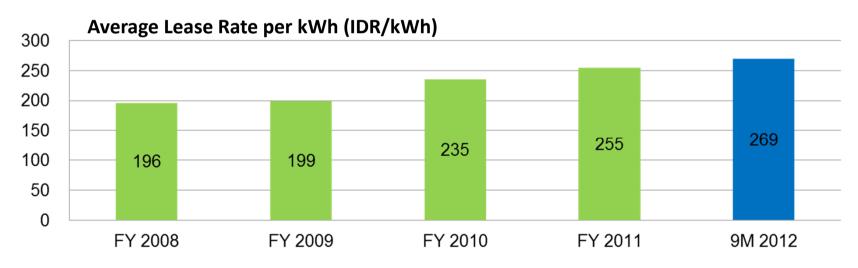


PT Sumber Daya Sewatama (SS) – Power Solutions



Revenue By Division and Key Customers



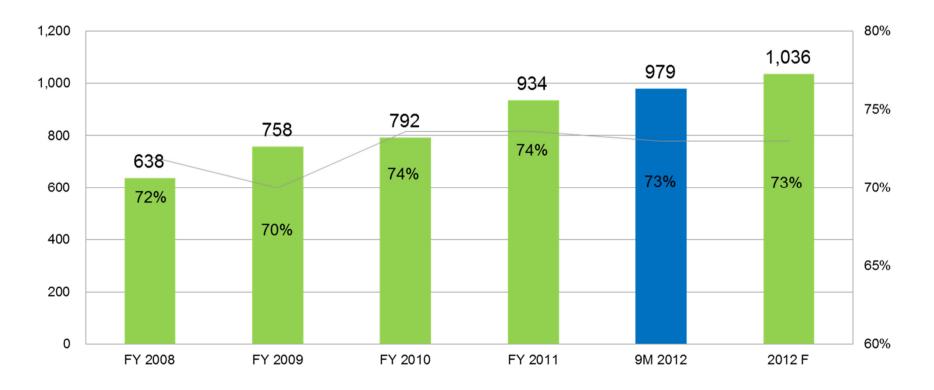

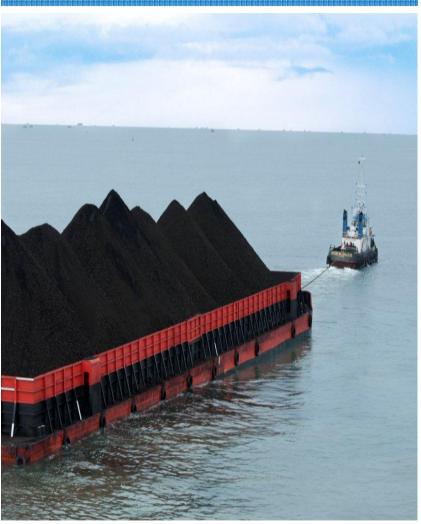
